This Addendum supplements terms and conditions that apply to your registration as parent or guardian ("Parent") on behalf of your athlete who you register as an individual participant (each a "Athlete") for the Elite 11 Finals offered by Student Sports LLC. ("SS")

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization ("WHO"). COVID-19 is reported to be extremely contagious. The state of medical knowledge is evolving, but the virus is believed to spread from person-to-person contact and/or by contact with contaminated surfaces and objects, and even possibly in the air. People reportedly can be infected and show no symptoms and therefore spread the disease. The exact methods of spread and contraction are unknown, and there is no known treatment, cure, or vaccine for COVID-19.
